1. **Call to Order-** Josh Purvis (Chairperson)

**Financial/Resource Allocation-**Dr. Witherspoon presented to the committee, the use of Title I carryover Funds from consumer constrictable resources for grades (3-5) Science material and the remainder on purchasing copy paper, etc.

**CCRPI-** Still waiting on score for school year 2014-15. Dr. Witherspoon will e-mail a copy of the results to the committee when they come in.

**Marquee-**Dr. Witherspoon shared with the committee the condition the old Marquee and the possibility of another grant proposal for the purchase of a digital marquee. He discussed the possibility of maybe using maintenance funds to purchase the new marquee sign. He will look into it and keep the committee informed.
